# Lions Bay Parking Plan Committee Meeting Thursday, January 7, 2016 at 7:00 p.m. Council Chambers

#### In Attendance:

- 1. **Call to Order** Meeting began at 7:00 p.m.
- 2. Appointment of Recorder Ruth Simons appointed
- 3. Approval of the Agenda Approved
- 4. **Public Participation** Doug Pollack no comment
- 5. Approval of the minutes from November 7<sup>th</sup> Approved
- 6. Business arising from the minutes review of action items:
  - Ruth handed out copies of what is printed from Eventbrite when guest parking is purchased on-line. There is no restriction on-line as to who can purchase.
  - Ruth handed out the updated Signage discrepancies report and explained that three items
    were added. This report is based on a drive around of the entire village noting obvious
    discrepancies in signage.
  - Current inventory of signs sitting at the Public Works Yard is still outstanding.

Action: HW to follow up on obtaining an inventory of what the Village current owns in terms of signs in storage.

#### 6.A Identification of parking classes.

KB explained his report was intended to ensure all types or classes of parking were
identified. Committee members had no more to add. He confirmed the report was to
list all possible types of parking and signage and was referenced from BC Highway
parking specifications. KB envisions changing all signage to more positive messaging,
but Committee and Council must first agree on the philosophy. This recommendation
could go into the report as a long term objective. KB reported the Infrastructure Master
Plan will be completed very soon and will influence parking in the future.

#### 6.B Metered parking.

- KB sent committee members a report summarizing his research on options for simple pay parking (refer to copy at end of minutes). Pay By Phone appears to be the simplest and least expensive but may require installation of a pay phone as backup for people without cell phone. KB agrees that any pay parking solution requires enforcement.
- RS suggested the quote obtained from Precise Parking in 2012 be considered, but KB said they would only provide update by meeting first in person.
- KB's provided a financial model (attached).
- Action: Committee members to review the report and simple pay parking options.
   KB to confirm set up costs.

#### 6.C Parking Survey Presentation.

- LN was unable to make the meeting due to illness but did pass along concerns about timeline requesting more time to analyse the survey results.
- HW presented the survey results as provided by Survey Monkey and handed out printed copies of all the comments. Ranking of priorities is still being compiled. LN will present further results next meeting.
- HW would like to present results from the survey to the Residents of Lions Bay. Format
  to be determined. Not all committee members support an open house or public
  meeting. It was suggested that we publish the results on-line.

#### **Actions:**

- LN to provide detailed analysis and report on the Parking Survey by next meeting.
- LN to confirm if responses were one per household and how this was managed.
- HW to do further analysis and find any correlations to help the analysis.
- Members to review comments which will be sorted and categorized.
- HW and committee to further consider the public presentation of the Parking survey results.

#### 6.D Summary of historical parking reports.

- Hard copies of a spreadsheet compiled by HW and RS were handed out. This sheet
  references available previous year's studies and resulting recommendations and
  categorizes the issues indicating the year and if the recommendations were
  implemented.
- RS commented that this list is not complete but helps to indicate the amount of work previously done on reviewing parking concerns, the common issues and what is still outstanding.

Action: KB offered to scan the binder of previous reports and emails and share the information with committee members.

#### 6.E Project Timeline.

- HW handed out updated timeline for the committee's Strategic Parking Plan. Timeline is tight to complete the report and HW was recently informed the next meeting date of Jan. 18 needs to be moved due to chambers being booked.
- Timelines to be further considered incorporating a phased approach.

#### 7. **Unfinished business** – Writing of the final report was discussed.

 HW had provided by email examples of reports from other communities and an outline of Key Components employed by other plans.

Action: RS offered to provide draft report outline using other Parking Plans as a benchmark.

#### 8. New Business -

- B. Future consideration HW explained that models of plans from other communities include future considerations which is something, other than the IMP, the committee has not discussed.
- C. Meeting dates Next meeting is changed from January 18 to January 25<sup>th</sup>.

- 9. **Public Comment and Questions** During the meeting Doug Pollock commented on concerns regarding pay parking for residents at parking lots. He provided personal examples and wishes that family and his members would not be inconvenienced by further parking restrictions. He currently purchases guest passes as needed.
- 10. Meeting was adjourned at 9:30 p.m.

#### **KB's Report re. Simple Pay Parking**

Fellow Committee members and staff, through the Chair:

As tasked by the Chair, I made brief enquiries at three paid parking system vendors to gather preliminary information on the types of paid parking offerings available, preparatory to our meeting this evening:

- 1. Precise Parklink has asked for a meeting, but I have not yet had substantive discussion.
- 2. The offering of Pay-By-Phone is surprisingly simple: for a \$1000 startup fee covering signage and back-end setup, users with the Pay-By-Phone smartphone app can pay for parking at Lions Bay lots, under any charge structure we want. Parkers not wishing to use the app can call an toll-free automated voice-rec system to pay by credit card on the municipality's merchant account. There are no monthly operating costs other than a \$100 minimum charge and we keep all revenue other than a \$0.35 per transaction convenience fee. Enforcement is simple too: our bylaw officer securely logs in with a smartphone or tablet for a list of valid parkers--all others are issued parking tickets. This solution only works for those with access to a phone.
- 3. Impark offers a hardware parking meter taking credit cards (85% of BC usage) and coins (15%). Meters cost \$11,000-14,000, and can be purchased outright, or rented over 3-5 years at approx. 20-80 revenue split (see business model analysis below). Monthly operating costs are around \$100/mo. The units utilise solar power and cellular modems, and most owners just take license numbers, no longer requiring a ticket on the dash or a stall number. Enforcement is again simple: our officer prints a list of valid parkers' license plates out of the meter (I believe integrated with the Pay-By-Phone offering above). Impark are the exclusive suppliers for T2-Systems machine, made in BC:
- 4. A simple business case shows good breakeven before enforcement, and if the main driver for paid parking is to control non-resident/guest parking, anything better than breakeven is good. It may be that the Committee recommends a non-metered Pay-By-Phone solution for one year to gauge demand. Upfront costs to resurface, line and sign paid parking areas may be in the \$25k range.

#### 1. Call to Order

Meeting was called to order at 7:03 pm.

#### 2. Appointment of Recorder

Regular recorder: Brian Ulrich

#### 3. Approval of the Agenda

The Agenda was approved as is.

#### 4. Public Participation

No questions or comments from the gallery.

#### 5. Approval of Minutes

Minutes from the previous meeting were approved as tabled at the meeting.

#### 6. Business Arising from the Minutes

- Ownership of #6 Bridge still unknown Nikii still investigating, with support from Fred.
- The missing third party validation report for our UV treatment systems was finally located and provided by James at the meeting.

**ACTION**: Brian to review and comment.

#### 7. Unfinished Business

#### A. Infrastructure Master Plan – Report from AECOM

An update to the previous progress chart was provided by James as well as village maps for the village water (desalination idea) and sanitary network proposals. Highlights from the update are as follows:

We went through each item on the progress chart again in order.

James quickly recapped our discussion of the Public Realm Corridor Management issue from last meeting – the proposal to enforce property lines so the Village can manage the use of road right of way for drainage, sidewalks, parking and services.

The update discussion started with Drainage given it is one of the pressing issues identified in the Public Realm. Each street in the Village has different nature and severity of drainage issues that will have to be prioritized. Tony suggested that it would be useful to have a street by street drainage strategy that uniquely addresses each specific drainage situation. James agreed that each drainage situation could be identified on the village map with color coding or other means to identify the priority of each area. He has identified the obvious drainage scenarios but suspect that there may be other less evident ones that the IC or residents know about, and would appreciate input on those for inclusion on the map.

**ACTION**: James to provide village map of drainage situations (issues) with priority (color code) and strategy for remediation identified for each. (i.e. street-by-street drainage strategy).

**ACTION**: IC and residents to provide input to James to be included on the drainage strategy map, if any are known.

**ACTION**: James to provide a cumulative properties serviced report (traffic, water, etc).

The IC marked up a village map with preliminary indication of the highest pedestrian routes where sidewalks would likely be needed first if they were to be installed. This will be included in James' cumulative properties serviced report (map).

#### Water

The opening comments to this item were that we have again, since the last meeting, had water system issues. Magnesia creek intake was still down as of this meeting and could not yet be safely accessed to evaluate the damage. Progress-wise, there was little new material to report from previous meeting. For a safe, quick preliminary assessment of the Magnesia intake situation, it was suggested that we send a camera drone up to photograph or video the area. At least we could then begin planning what will be need to be done once we can safely access it again.

**ACTION**: Nikii would be putting forward a budget request to procure a drone to enable quick and safe preliminary assessments of areas (in the specified instance Magnesia) when crews cannot investigate in person due to our safe working protocols.

#### **ACTION**: Nikii also to provide the IC information on infiltration galleries.

Karl would like to continue investigation of vaults under the streets for services despite previous indications that it was not practical. If we are digging up the roads we should also put in the power and utilities (underground). What all can be included in the vaults is central to this question. Can sanitary (sewer) lines be placed in the same vault as potable water lines? If the answer is 'no' then the idea is a non-starter. Without vaulting, Lions Bay is not likely to go to underground power lines in the near or even long term.

The next item, proposal to raise procurement level from \$2K to \$10K and the establishment of a preferred vendor list were noted to be more of an Administration task than an IC task. Move item off IMP and transfer to Village staff.

#### Metering

Per last meeting, Zone metering locations will be suggested by AECOM in the IMP. New to the discussion on metering is the consideration of the requirement for backflow prevention to avoid contamination of the mains by water flowing back into them from private residence lines. Meters generally prevent backflow and would address this requirement. If the type of meters considered do not prevent backflow, a check-valve would be mandated with any installation of meters.

Karl also observed that our conclusion that residential water metering is not worthwhile may change in the face of a central sewer project. In that situation we would be paying to process all the water in the sewage plant therefore we would definitely want to minimize consumption.

#### Treatment

James had looked into a single desalination plant as our primary treatment system with UV as backup, and indicated that there are <u>lots</u> of provincial hoops to jump through. This is not really what the IC was thinking or expecting but per his understanding of our requirements, it is definitely a more reliable and secure system, albeit more costly to implement. Even with filters upstream of our UV systems to reduce turbidity (which we all agree we <u>should</u> have), debris coming down the creek can still plug or damage our intakes, render the system inoperative. Safety issues to access the current intakes is still an ongoing issue as well.

In the interim, Karl suggested that our safety of access problem could be addressed by installing avalanche sheds over the access roads in the sketchy areas.

The IC recapped the main goal of the water treatment section of the IMP: we're looking for a plan that deals with our overall supply issue, dealing with safety, quality and reliability of our supply. So far the only options different from what we have now are:

- -One primary UV plant with filtering (and one backup)
- -Permanent Desalination plant
- -Temporary Desalination plant for peak shaving

The problem with one UV system on standby (backup) is that it takes up to 5 days to get water samples processed and approved before the unit can go online.

Although we all like the idea of a dedicated desalination the initial cost is a big concern. In view of this, James recommended that he do a detailed evaluation of a desalination solution that could be in place 5 years from now – separately from any proposal to address our immediate needs.

**ACTION**: James to provide an option for desalination, but he felt that (should the Village still wish to pursue the concept) detailed design might be better spent in 5 years' time – when there might well be more options available.

#### Sanitary

James tabled a diagram (map) with the concept for a village-wide sanitary network with estimated costs.

As mentioned in previous discussions, many if not most, septic systems in the village are near or at end of life and need to be replaced at an average cost of \$40K-\$50K, and residents will be hesitant to then spend another \$12K afterward to connect to a new central system. Tony pointed out that \$20K from each residence avoids a full replacement cost and generates \$10M that could pay for a full central sewer system. Timing is the issue and such a plan would have to be implemented as soon as possible before more residents replace their own systems. Further consideration required.

The IMP update was concluded with agreement that James needed some help from us to prioritize the issues. A quick discussion made it clear that we were not sure which issues were priority:

- -Roads/drainage (surprisingly this is probably #1 given discussion to date)
- -Water (previously thought to be #1, but now likely is not)
- -Sewer
- -Other

**ACTION**: Nikii to help James prioritize the issues for final report.

The final IMP from AECOM is a few weeks late. However, the IC acknowledged that we did not provide direction as was specified in the contract that we would. We (the IC) all agree that we would rather the Plan be done right rather than delivered prematurely so we are ok with it being a few weeks late.

In view of this, the revised due date for the IMP was set at 14 January 2016.

Next meeting will therefore be moved from the 2<sup>nd</sup> Monday to the 3<sup>rd</sup> Monday (January 18<sup>th</sup>) to accommodate the new due date but still provide review before submitting it to council.



Lions Bay is unique in its Regional District, Metro Vancouver, in that it is located within the defined Urban Containment Boundary but outside the Greater Vancouver Sewerage and Drainage District and Greater Vancouver Water District. Lions Bay completed its current OCP in 2009. The next iteration is planned for 2016. This amended RCS therefore includes work-towards statements that will inform the next OCP.

At the 2011 federal census, Lions Bay had 1,318 people living in 556 private dwellings, a slight decline in population, and increase in age, from the censuses of 2006 and 2001. Lions Bay seeks to reverse this trend, to maintain a thriving "complete community." In mid-2015, the Village had four commercial enterprises (a marina, a boat service centre, a general store & café, and a real estate office), plus numerous home-based businesses. Due to topography and limited supply of land, there are limitations to growth. Long term (2040) potential population may be 1600-1800 residents and 700-800 residences. Village attributes include:

- Magnificent views
- Abundant trees
- Adequate clean water
- A modern highway accessing downtown Vancouver in 30 minutes (and Squamish in 40, Whistler in 70)
- School District 45's Lions Bay Elementary School with capacity for 60 K-3 students (enrollment in 2015 was 32).

#### Municipally-owned assets include:

- Lions Bay Village Hall
- Klatt Public Safety Building1
- Frank Smith Works Yard
- Lions Bay Field (a joint use soccer-size playing field shared with the school)
- Sand or gravel beaches at Main Beach (up to 50 resident parking spaces, 30 potentially paid non- resident parking spaces, washroom and three separate play structures), Kelvin Grove (15 free parking spaces, washroom, off leash dogs allowed) and Brunswick (limited non-resident parking).

- Three buildable lots, plus six in the Crystal Falls neighbourhood currently overlaid by a private road and bridge
- A single unlit tennis court (limited on-street parking, single, recently resurfaced and unlit)
- Centennial Trail, Pride Trail, Isleview Trail and numerous volunteer-maintained trails outside the Village limits.
- Wade Park
- A small secondary WWTP serving 100 of the Village's 550 homes.
- A fire-training facility on Crown leased land at the "Upper Brunswick" gravel pit.

The Greater Vancouver Regional District's RGS, *Metro Vancouver 2040: Shaping Our Future2*, outlines a regional vision—unanimously endorsed by all member municipalities--of achieving "the highest quality of life embracing cultural vitality, economic prosperity, social justice and compassion, all nurtured in and by a beautiful and healthy natural environment." *Metro 2040* lays out five fundamental goals to achieve this vision. Lions Bay's current OCP and future update addresses these goals with the following approaches:

#### GOAL 1: Create a Compact Urban Area.

Metro Vancouver's growth is concentrated in compact communities with access to a range of housing choices, and close to employment, amenities and services. Compact transitoriented development patterns help reduce greenhouse gas emissions and pollution, and support both the efficient use of land and an efficient transportation network.

The intent of this goal is to focus urban development within the "Urban Containment Boundary" in "Urban Centres" and "Frequent Transit Development Areas," with access to a range of housing choices close to employment, amenities and services.

Although Lions Bay is designated "General Urban" in *Metro 2040*, it has no Urban Centres or Frequent Transit Development Areas. Lions Bay is surrounded by Electoral Area A, and is separated from its nearest Metro neighbour municipality, West Vancouver, by 12 km of highway. With its small size (2.53 sq.km) Lions Bay's impact on regional growth is low, and it is unlikely to draw significant urban development.

Nevertheless, Lions Bay is open to densify, both to increase the tax base, and to produce a more complete community, and has recently formalized secondary suites. The 2016 OCP update will explore if there are suitable parts of Lions Bay for rezoning to multi-family, Crown lands to extend municipal boundaries into, and land grants and swaps to achieve.

The future OCP will consider steps that are consistent with this goal, considering development applications in the Upper

GOAL 3: Protect the Environment and Respond to Climate Change Impacts.

Metro Vancouver's vital ecosystems continue to provide the essentials of life – clean air, water and food. A connected network of habitats is maintained for a wide variety of wildlife and plant species. Protected natural areas provide residents and visitors with diverse recreational opportunities. Strategies also help Metro Vancouver and member municipalities meet their greenhouse gas emission targets, and prepare for, and mitigate risks from, climate change and natural hazards.

STRATEGY 3.1 Protect Conservation and Recreation lands

STRATEGY 3.2 Protect and enhance natural features and their connectivity

STRATEGY 3.3 Encourage land use and transportation infrastructure that reduce energy consumption and

Regional strategies to achieve this goal focus on protecting Conservation and Recreation lands, which includes enhancing natural features and their connectivity. The intent is also to encourage land use and transportation patterns that reduce energy consumption and greenhouse gas emissions and enable municipalities to mitigate and adapt to climate change and withstand risk of natural hazards.

As identified on RCS Map 1, there are no regionally-designated Conservation and Recreation areas within Lions Bay, but Lions Bay is surrounded by regionally-designated 'Conservation and Recreation' lands and supports the principles behind the designation, including a buffer for urban growth as stated in OCP Policy 4.2. Lions Bay plans to explore expanding its municipal boundary to provide more municipal influence over its 'green belt' in meeting environmental protection objectives, not for urban development.

Policies 4.2 (a) and (b) of the current OCP encourage conservation and stewardship of the watershed areas both inside and outside the village boundaries. Lions Bay's three watersheds with provincial water licenses on Magnesia, Alberta and Harvey Creeks are designated Conservation and Recreation in *Metro 2040*. Harvey and Magnesia creeks have wide riparian areas designated as Conservation/Watershed Protection on the 2008 OCP Land Use Map. None of these streams are salmon-bearing, and all three were channelized in the 1980s with large debris catchment basins built on

### greenhouse gas emissions, and improve air quality

Harvey and Magnesia. The 'Watershed' zone in the Zoning Bylaw is now obsolete since the water intakes have moved higher upstream. The 2016 OCP update will further address how the streams will be protected to prevent erosion and provide a channel for potential debris flows.

Since Lions Bay is not supplied with natural gas, home heating is a combination of oil furnace, electric baseboard and wood. Both wood and oil produce GHGs, so Learn to Burn, woodstove upgrade and oil furnace replacement campaigns will be undertaken as resources allow.

With the advent of the BC Hydro Net Metering program, mini- and micro-hydro projects become more feasible, and Lions Bay will investigate opportunities for generating energy using its water intake piping and nine large pressure- reducing valves. Policy 4.7i of the current OCP commits the municipality to explore opportunities for small-scale renewable power generation.

Policy 4.7i states a continued focus on reduction, re-use and recycling of solid waste resources, aimed at addressing GHGs from solid waste, focusing on increasing waste diversion through recycling and organics pickup, now a mandatory part of Metro Vancouver solid waste bylaw.

Through protection policies and implementation tools to be implemented in a new "Trees, Views and Landscapes Bylaw," Lions Bay will address the management of its significant tree resources.

Climate change impacts are hard to quantify, but Lions Bay is aware of the risks of sea-level rise, more intense flooding, erosion, subsidence, mudslides, and fire.

The 2016 OCP update will work towards policies that address the management of riparian areas, ravines, steep slopes, other hazard areas, and intertidal areas through the application of Development Permit Areas.

The 2016 OCP update will also consider additional non-vehicular GHG reduction targets and actions.

STRATEGY 3.4 Encourage land use and transportation infrastructure that improve the ability to withstand climate change impacts and natural hazard risks

Policies 4.2a and b of the current OCP encourage conservation and stewardship of the watershed areas both inside and outside the village boundaries.

Policy 4.2d states the municipality should create a plan for Wildfire Interface protection.

Through policy changes in the OCP update, Lions Bay will encourage modest intensification of its existing residential areas and avoid development of areas associated with landslide and wildfire risk. Update(s) will also address flood control and oceanside setback requirements to address risks of sea-level rise.

As stated in policy 4.2 n, Lions Bay will continue to protect the riparian area of its creeks and the creeks themselves as channels for potential debris flows. As funding permits, Lions Bay will continue to consider improvements to road drainage to address potential increases in storm-water runoff resulting from higher rainfall intensities associated with climate change.

GOAL 4: Develop Complete Communities.

Metro Vancouver is a region of communities with a diverse range of housing choices suitable for residents at any stage of their lives. The distribution of employment and access to services and amenities builds complete communities throughout the region. Complete communities are designed to support walking, cycling and transit, and to foster healthy lifestyles.

STRATEGY 4. 1 Provide diverse and affordable housing choices

STRATEGY 4. 2 Develop healthy and complete communities with access to a range of services and amenities

*Metro 2040* identifies a need for complete communities, with a balance of jobs, housing opportunities, and services.

Lions Bay is largely residential, and most residents access employment and services outside the Village. Currently, the housing stock is largely single-detached and 86% is owner occupied with the remaining 14% rented. Only 25 of 550 units are condominium. 23% of tenant households spend 30% or more of household total income on shelter4.

Policies 4.3a and 4.3b of the current OCP speak to providing for secondary suites and exploring limited opportunities for development to increase housing options. A draft land use strategy explores a variety of additional housing forms and will be considered as part of the 2016 OCP update.

Lions Bay's 2016 OCP update may designate new development areas, consider redevelopment of the Public Works yard, and possible long term use of the Upper Brunswick, Crystal Falls and Brunswick Hill (the "gravel pit") for a range of municipal and residential alternatives. The 2016 OCP will further consider providing for secondary

suites, rezoning single family to duplex, and limited development opportunities that will enhance housing options.

Policy 4.4(e) of the OCP provides for enhancing school viability and the provision of other social, recreational, and cultural activities for an increased population. Lions Bay's vision is of residents living out their whole lives here, with in-Village shuttle assisting people to get around the steep terrain, aged- and assisted living facilities, entry-priced housing, and enhanced hiking trails.

The 2016 OCP update will set out a vision for Lions Bay that seeks to:

- Define and foster community values
- Grow tax base, and accommodate a wider crosssection of population. Possible avenues include amalgamation, encouraging selective development and densification.
- Promote active lifestyles
- Become financially sustainable.
- Clarify land use and rezoning policy for new housing options

GOAL 5: Support Sustainable Transportation Choices.

Metro Vancouver's compact, transitoriented urban form supports a range of sustainable transportation choices. This pattern of development expands the opportunities for transit, multipleoccupancy vehicles, cycling and walking, encourages active lifestyles, and reduces energy use, greenhouse gas emissions, household expenditure on transportation, and improves air quality. The region's road, transit, rail and waterway networks play a vital role in serving and shaping regional development, providing linkages among the region's communities and providing vital goods movement networks.


Metro 2040 promotes land use and transportation planning that enables alternative choices to the private automobile, such as transit, cycling and walking, while ensuring the efficient movement of people and goods throughout the region. Due to Lions Bay's location, most residents depend on private vehicles, but the municipality has worked and will continue to work with TransLink to enhance transit service to the Village. The municipality will also look at an in-Village on-demand shuttle service to enhance mobility. A rideshare parking program is in place, and Lions Bay will look to add paid parking lots.

Section 4.6 of the current OCP includes policies that recognize the role, jurisdiction and access to the Sea to Sky Highway 99 (4.6a), encourage multi-modal transportation solutions in the corridor (4.6b), greater transportation choice including car pooling, park & ride, shuttle buses (4.6c) and further development of linked pathways (4.6e) and hiking trails (4.6f).

The 2016 OCP update will consider policies related to goods movement.

Re: 2016 FCM Resolution - Build Canada Grant Funding

Township of Langley Council, at its Regular Afternoon Council meeting held on January 11, 2016, adopted the following resolution requesting Metro Vancouver municipalities' endorsement:

THAT Council make the following motion to the Federation of Canadian Municipalities:

WHEREAS the Federal Government's Build Canada Grant Program generally shares the costs of all approved infrastructure projects equally between the province or territory, and local jurisdiction at one third each;

AND WHEREAS for nationally and regionally significant projects, where projects provide a greater national and regional benefit, and where communities are disproportionately and directly impacted by such projects, the burden of one third of the cost is inequitable and too high for the local jurisdiction;

THEREFORE BE IT RESOLVED that the Federal Government's Build Canada Grant Program's National Infrastructure Component be amended to fund a greater percentage share than the current one-third component by the Federal Government, based on criteria including affordability of the community in which the project is to be constructed;

THAT this motion be forwarded to Metro Vancouver municipalities to request their endorsement; and

THAT this motion be forwarded to local members of parliament.

Dear Mayor and Councillors,

The United Nations Trafficking in Persons Protocol has established the most widely accepted international definition of human trafficking and a **4 pillar approach** to combat human trafficking. (Their link: <a href="http://www.unodc.org/undoc/en/treaties/CTOC/index.html">http://www.unodc.org/undoc/en/treaties/CTOC/index.html</a>)

The 4-P's are:

- 1. Prevention of human trafficking
- 2. Protection of victims
- 3. **Prosecution** of offenders
- 4. **Partnerships** with others

We would encourage your Council to evaluate specifically what you are doing in each of these areas.

**Prevention** involves raising awareness; which is what we are trying to do throughout BC with our information emails. Reaching out to the schools in your communities will be a key. Our youth are very vulnerable. **We believe education is our greatest weapon**.

**Protection** of victims and **Prosecution** of offenders is the intent of Bill C-36 (a form of the Nordic Model of Law) "The Protection of Communities and Exploited Persons Act". We believe police forces and judges need to be mandated to enforce this Federal Law. Until they do, trafficking will continue unabated in BC, because Human Trafficking is very lucrative and traffickers will have no incentive to curb their activities

and criminality.

**Partnerships** are crucial to stopping Human Trafficking. We are grateful for the passing of the Resolution B53 (and B80) at the recent UBCM Convention, but would now encourage cities and municipalities **to implement** these Resolutions, and to **prepare a Resolution for the National FCM**.

# HUMAN TRAFFICKING AND SEXUAL EXPLOITATION IN CANADA AND LOCALLY

#### **Topic Summary:**

Human Trafficking is the recruitment, transportation, or harboring of persons for the purpose of **exploitation**, typically in the sex trade or forced labor. It is the fastest growing and one of the most lucrative criminal enterprises globally. This form of **modern day slavery** occurs daily in Canadian communities.

The Criminal Intelligence Service of Canada estimates that a single Canadian victim of sex trafficking is worth approximately **\$280,000 per year** to her exploiter. Middle class females between ages 12-25 years of age are being recruited by male peers. Victims are controlled through direct (rape, assaults) and indirect (threatening family members) forms of coercion. The daily earning off of one victim can range from \$300-\$1500 and the average age of entry into the sex trade in North America is 12-14 years of age.

#### **Action Victories-**

Bill C-36 passed by the Federal Government in December, 2014.

To address the issue of prostitution, The Federal Government of Canada passed Bill C-36 December, 2014 which

- 1. Targets the buyer of sex; the predator, pimp, trafficker, john are criminalized
- 2. Recognizes the seller of sex is a victim; usually female and is not criminalized
- 3. Exit strategies put in place to assist the victim out of the sex trade.

It is called the "Nordic Model of Law" and is successful in Sweden. This is in contrast to "the New Zealand Model" or decriminalization of prostitution, or legalization of prostitution as currently exists in the Netherlands and Germany.

#### The Facts-

#### **Facts: about Prostitution and Sex Trafficking**

Human sex trafficking is the fastest growing crime in the country and the world.

People everywhere in this world are being bought and sold like merchandise. Men, women, children. 30 million to date is a conservative estimate. This is **MODERN DAY SLAVERY**.

Today's new slavery has low costs and huge profits. In Canada, a pimp, trafficker or predator will earn about \$280,000 per year, per victim. The average pimp will have 4-5 girls working for him as prostitutes.

In Canada the average age of entry into prostitution is 14-16 years of age. However, every year it is younger and younger. Johns, pimps and predators prefer younger girls because they are disease free and easy to manipulate. For aboriginal girls it can be as young as 7-11 years old.

The vast majority (89-98%) of prostituted women are lured, tricked or trafficked into prostitution. **It is not a choice.** The pro-prostitution lobby is strong and well financed. They have "prostitutes" or "sex workers" speak publicly that they "chose" this profession; but they only represent 2-8 % of prostituted women. 89-98% who did not choose prostitution as a lifestyle cannot speak for themselves. They are the voiceless majority.

92% of prostituted women would quit immediately if they could. It is easy to enter prostitution and very difficult to get out.

85% of the prostituted were sexually abused as children.

In BC, as in most of Canada, Aboriginal women are grossly overrepresented in prostitution and trafficking. In BC, look at the Downtown Eastside in Vancouver and the Highway of Tears (the long islolated stretch of Highway #16 from Prince Rupert to Prince George).

Trafficking of girls and women is driven by the demand to buy sex. The internet is fueling this demand through pornography. Pornography creates sexual appetite, and this causes a dramatic demand for sexual services. Result? The supply has to increase. Where does this supply come from? Local girls and women are now being targeted here in Canada to satisfy the rapidly growing demand for paid sex. Sex recruiters even stand outside high schools and in malls...

In the countries where prostitution is legalized: the Netherlands, Germany, Australia, New Zealand, human trafficking has exploded. Child prostitution has exploded, and sex tourism has exploded. Organized crime increases and crime syndicates move in.

Since we have such a long border with the USA, if Canada legalized prostitution, Americans would come to Canada in huge numbers for sex tourism.

The pro-prostitution lobby state that prostitution can be "safe" with appropriate employment laws. Employment laws do not apply to prostitution because prostitutes are "independent contractors" and do not fall into traditional employer/employee roles.

**The magic trio**: wherever there are drugs, gangs and prostitution, there is trafficking. There are serious gang issues in all of our Canadian cities.

RCMP estimate 15,000-20,000 missing children in Canada currently per year. This is considered a conservative estimate. These children are probably trafficked. In the USA it is 100,000-300,000 missing children per year. Think about that number; it is the size of a good-sized city.

Of deepest and recent growing concern is the sudden and dramatic increase in child porn: production and consumption. Statistics show that once men start

viewing child porn, a very high percentage will act out and assault a child with I year ("Pornland", by Dr. Gail Dines- expert in the world on pornography research).

The average life span of an adult in the sex trade is 7 years; then they are murdered, commit suicide, become mentally ill or are drug addicted. Very few escape the lifestyle successfully. The average life span of a child caught up in the sex trade is 2 years; they are beaten to death, contract HIV/AIS, contract bacterial meningities, or overdose on the drugs forced on them.

# When children are involved in the sex industry, this is an indication that society at its core is no longer vibrant, healthy, safe or working.

Nail spas, massage parlours, casinos, escort services, modelling agencies with their ads are popping up everywhere. There is "brothel" activity often associated with these "businesses". Municipalities issue the business licenses.

Politicians, law enforcement and judges need to make the connections between pornography, prostitution and trafficking. They form a toxic lucrative mix that profits organized crime.

There is only 1 human trafficking conviction in BC (compared to numerous convictions in all the other provinces); Reza Moazami, a 29 year old male from North Vancouver. He had a "stable" of 11 girls, 9 of them underage. He had these girls sexually servicing men from hotels and condos in North Vancouver, Vancouver, Richmond, and Nanaimo.

According to Vancouver police officer, Rich Akin, human trafficking is happening in every community in BC. Every home has a computer. **Every computer has a red light district**.

The pro-prostitution pro-brothel lobby is strong and well-supported financially. This lobby frequently overwhelms the media with their point of view. There is a huge effect and influence of pornography, prostitution, trafficking and the sex industry on our culture today. These activities must not become "normalized". With the apparent re-sexualisation of women and girls today, this is a very real and tangible fear.

Language is very important. Pro-prostitution lobbyists call prostitution "sex work". It is not work; it is exploitation, degradation, commodification of women and girls (in its most heinous form) in order to please men.

#### A (Personal) Action Plan: What can be done to stop Human Trafficking

- 1. Tell someone: share what you have learned with your family, friends or colleagues.
- 2. Help frontline workers, NGO's and the organizations that help survivors by volunteering your time, language abilities, or professional skills. Donate money, clothes, or equipment to them, and perhaps plan a fundraising event to help one of the organizations listed.
- 3. Raise awareness; host an awareness event with your friends, work associates, church group, or service club to tell them about human trafficking and commit to doing something to address the problem. Have a movie night, ie. "Red Light, Green Light", with discussion afterwards.
- 4. Call for change; email, call, and/or write a letter to your municipal, provincial/territorial, and federal politicians asking what they are doing to address the problem of human trafficking, and ask them to implement the

- recommendations for government shown above- the are supposed to be working for you, after all. (ie. We have new Federal MP's now).
- 5. Take a stand; become an advocate for Bill C-36, for any anti-human trafficking policies, and support exit programs for prostituted/trafficked women.
- 6. Buy fair trade products where possible.
- 7. Speak up; raise the issue of human trafficking in letters to the editor, at political debates, in the classroom and at town hall meetings.
- 8. Be a woman against human trafficking; talk to you husband, boyfriend, partner, or male friends and family members about the realities of women and girls exploited in the sex industry.
- 9. Be a man against human trafficking; Don't pay for sex or go to places where commercial sex acts take place, either in Canada or when travelling abroad, and discourage your friends from doing so if you are invited to go along to such places. Explain your concerns. Watch Dr. Jackson Katz TEDtalk on men, violence and silence.
- 10. Report it. Know the warning signs of human trafficking in your community, at work, and when travelling. Call the police immediately.

#### What parents can do to protect their children:

Educate yourselves about the issue. Read the resource page included here.

If you have concerns about someone being trafficked or sexually exploited, call Crime-Stoppers to report: 1-800-222-8477, Kids Help Phone: 1-800-668-6868.

Take the BC OCTIP Human Trafficking Awareness Online Program offered for free by the BC Ministry of Justice. Google it- it is easy to find!

Research anti-trafficking organizations in this community. Get involved with the human trafficking/sexual exploitation issue by supporting organizations who are addressing it; volunteer, fundraise, lobby on their behalf.

Watch videos (most can be Googled), for example: Hope for the Sold's documentaries' "Enslaved and Exploited" and "Red Light Green Light". Shared

Hope International documentary, "Chosen". Documentary "Nefarious", National film Board Documentary "Buying Sex".

Online watch 2015 CNN special report called "Children for Sale: The Fight to End Human Trafficking" produced by Jada Pinkett Smith.

Educate your children. Pimps and predators will recruit children as young as 10 years of age. Give your children and grandchildren the love and hope they need so they can dream, thrive and reach their individual and awesome potential. Monitor your children's outings: Are they with a trusted adult? Are they alone? Stay connected with your children. Know where they are and what they are doing.

Hang out with your children and grandchildren. Sit and listen to your children. Let them talk to you. If you don't, some "pimp" will.

Know your children's friends and their parents.

Watch your daughters, specifically for older boyfriends. Older boyfriends can be pimps who do not kidnap, but who manipulate.

Internet safety- There are websites to help parents protect their children. Learn how the internet works, and its strengths and weaknesses. Be computer literate, for your children's sake.

Children need to understand the danger of posting pictures online. These photos can put children at risk.

Have open communication with your children and build bridges of trust and unconditional love for your children.

### Key Contacts for Action-Government contacts (e.g. PM, Opposition a Leader, cabinet minister, etc.)

In the fight to end Human Trafficking in Canada, it is important to involve all 3 levels of government; **municipal, provincial and federal.** This issue can only be solved with a **collaborative approach**. Police, Educators, Judges, Health Practioners also have contributing roles in exposing and addressing human trafficking in their respective domains. Please write these leaders!

Education is our greatest weapon. Raising awareness of the problem is a first step. A robust letter writing campaign has huge impact. Concerned citizens need to contact their local City Councillors and Mayors, their local MLA's and MP's, as well as Provincial/Federal Ministers of Justice, Ministers of Health, Ministers of Education, Ministers of Family and Child Development, Minsters of Aboriginal Affairs, and Ministers of Public Safety. Write to your Provincial Premier and to the Federal Prime Minister. It is easy to Google their contact information, email addresses and street addresses. Courteous, factual emails and letters go a long way to effect change. We have a "working democracy" and it is important that citizens use their rights to access and inform elected officials.

This letter below is a sample of what can be written and mailed or emailed (do both!) to local municipal City Councillors and Mayors, MLA's, and MP's., Premiers and the Prime Minister.

# Letter to Government leaders in Support of Abolition and Bill C-36; the "Nordic Model of Law"

Dear	Date:
I write with regard to the Decer	mber 2014 decision by the Canadian Parliament establishing Bill
C-36 "The Protection of Commu	unities and Exploited Person Act". I strongly urge you to work
with your colleagues to enforce	and endorse this law addressing prostitution based on the legal

and social framework of the Nordic Model of Law implemented in Sweden in 1999. This Model of Law, often called the Nordic Model, is based on the recognition that prostitution is a form of sexual exploitation and violence against women and girls. It penalizes the buyers of sex (johns, pimps, predators), while decriminalizing those who are being sold.

I ask you to support the lead of Sweden, Norway and Iceland (nations with stable democratic traditions) who have this legislation successfully in place that follows this model. Each country has seen a reduction in prostitution and sex trafficking and increase in the stigma of buying and selling of people for sexual acts since enacting this legislation.

We must continue to take a firm stand against the demand for paid sexual access to women and children.

Countries that have legalized or decriminalized prostitution (New Zealand, Australia, Netherlands, Germany etc.) have seen a dramatic increase in Human Trafficking, child and juvenile prostitution, illegal brothels and organized criminal activity.

The former mayor of Amsterdam called the experiment with legalization "an abysmal failure" due to the increase in organized crime, human trafficking and drug trafficking. The city of Amsterdam has already closed one third of the Red Light Districts in hopes of curbing criminal activity. In New Zealand, the Legal Brothel Owners Association has complained of Chinese women being trafficked into the country, undercutting their prices, and being coerced to offer riskier sex acts. These are just two current examples that demonstrate the fact that any time prostitution has been legalized there is an expansion of both the legal and illegal industry, an increase in human trafficking and a normalization of sexual exploitation.

Prostitution is a form of systemic violence against women and children and a major deterrent to women's equality. As a world leader, Canada has the opportunity to model sexual equality because it has clearly named prostitution as a violation of women and children's right to safety. The Government of Canada has rewritten our laws to reflect this fact, and we request all levels of government (municipal, provincial, and federal) to continue to support these laws, raise awareness about these laws and to train our police forces and judges in the prosecution of these laws. I desire to see **Prevention** and increased education about this issue, **Protection** of victims, **Prosecution** of traffickers and an increase in **Partnerships** that promote cooperation among countries in order to stop prostitution and sexual exploitation.

In the vast majority of cases, prostitution cannot be viewed as a choice but rather a lack of choice due to systemic issues including-but not limited to- gender inequality, poverty and racial discrimination. The laws of Canada must protect victims of exploitation rather than reinforcing their marginalization.

Aboriginal women and children are disproportionately overrepresented in street prostitution as a result of far reaching systemic injustices. These same injustices have also resulted in the hundreds of missing and murdered Aboriginal women and girls that have recently been brought to international attention. In criminalizing the demand for prostitution and decriminalizing the prostituted, Canada has an opportunity to demonstrate its commitment to addressing the systemic injustices that so profoundly affect all Aboriginal peoples, but Aboriginal women and children in particular.

The September 2014 UBCM (Union of British Columbia Municipalities) convention for civic leaders recently passed the following B53 on Human Trafficking: **Therefore be it resolved that UBCM call on the RCMP, local police forces and local governments to continue to work** 

collaboratively in order to implement the recommendations found with in the National Task Force on Sex Trafficking of Women and Girls in Canada's recent report (NO MORE" Ending Sex-Trafficking in Canada) as well as the Province of British Columbia's Action Plan to Combat Human Trafficking.

As a constituent, I strongly urge you to speak out and act to protect the vulnerable (especially women and children) by actively endorsing and enforcing the Criminal Code (Bill C-36) to criminalize the purchasing of sex and decriminalize the person being sold. I encourage you to read and implement the recommendations in the above 2 reports.

Her expectations of helping to rebuild a devastated country are dashed when she uncovers a dangerous reality of corruption, cover-up and intrigue amid a world of private contractors and multinational diplomatic doubletalk.

Further to North Vancouver City Council's resolution on January 18, 2016 (attached), I am writing to provide feedback and recommendations regarding the Building Act under implementation. The City of North Vancouver appreciates and supports in principle the three pillars of the new Building Act: consistency, competency and innovation. We wish to offer feedback and recommendations to assist the Province in rolling out the Act in such a way that unintended consequences are avoided.

#### 1. Innovative technologies and innovative urban form

The City of North Vancouver has built a strong reputation working cooperatively with the development and construction industry to ensure flexibility and efficient service, while meeting consistently high standards and sustainability targets. The City has repeatedly won the "Most Business Friendly" Award for Municipal Excellence from NAIOP (the Commercial Real Estate Development Association) and Business in Vancouver, including the most recent award years 2015 and 2014. Part of the City's success in this regard is the City's Inspections staff's willingness to use the Alternative Solutions pathway to meet the requirements of the BC Building Code while protecting the City's high Code compliance standards. The City's record in achieving good flexibility and customer service may be difficult to continue, as the capabilities of the Alternative Solutions pathway are at risk of being limited in future as a result of the new Building Act. It may therefore be more difficult for City staff and Council to respond to innovative technologies or innovative urban forms being promoted locally by the development community. We are hopeful that the Alternative Solutions pathway will not be unduly limited by ministerial regulations and that the alternate Provincial innovation review processes will be cost-effective and time-efficient.

#### 2. Incenting energy efficient buildings

The City has been a leader in climate mitigation in Canada. Action is required to reduce building emissions if we are to achieve our Provincially-mandated greenhouse gas (GHG) emissions reduction targets and help minimize the effects of climate change. The City's Zoning Bylaw currently provides a density bonus in return for achieving a higher energy standard (i.e., lower GHG emissions). This practice has been recognized by NAIOP, the Union of BC Municipalities and the BC Community Energy Association. Under the BC Building Act, the City's current bylaws that provide for enhanced energy efficiency in buildings will become invalid. To date the Province has not been willing to confirm the City's ability to continue to use the density bonusing tool, as set out in s. 904 of the Local Government Act, for enhanced energy efficiency. The City respectfully requests further clarification with regard to these LGA provisions.

#### 3. Policy impacts

It appears that a number of City policies could significantly be affected by the Building Act, including but not limited to the City's Adaptable Design Policy, the Enhanced Building Security Bylaw, City urban design guidelines (e.g., our ability to accommodate grade changes related to flood prevention), Solid Waste/Recycling Guidelines, and Active Design Guidelines. As these requirements are "building-related" (which is not defined in the Act) and in bylaw form, they are at risk of being rendered invalid on December 15, 2017. Due to a shortfall of detail and communication from the Province, there is very little to assist local governments with the bylaw review that the Province is encouraging. Changing municipal bylaws, and particularly zoning bylaws, is a lengthy process with significant statutory consultation responsibilities including public hearings and media notifications. To have to potentially change bylaws twice because we do not have all the details yet would be extremely challenging. We request further detail on a clear communications path on "what happens when" with regard to implementation so that our City can chart a path forward.

#### 4. Additional requests

There are a number of other City initiatives that will potentially be impacted by the Act, but we and other BC municipalities currently lack specifics on how the provisions of the Act will be applied. Additional details are needed in order for municipalities to be able to conduct bylaw reviews. In particular:

- a) The Province is creating a guide for local governments on the Building Act. However, the sections of the guide that explain how local governments will be affected by the Act and how they can apply for a variation to the requirements of the Act is still in development. The guide is not anticipated to be available until spring 2016. We request that the guide be made available sooner, or that the two-year window to change all bylaws before they become invalid be extended.
- b) It is our understanding that opt-in Provincial regulations for enhanced energy performance and enhanced sprinklering are in development but have not yet been finalized. We request that the regulations and the municipal tools be finalized now, or that the two-year window to change all bylaws before they become invalid be extended.
- c) There is a need for a clear and transparent commitment by the Province to review and update certain elements of the Building Code on a continual learning basis, or at least on a three-year cycle (e.g., energy efficiency requirements). Emerging safety concerns, technological innovation and new opportunities should also trigger general Code reviews and consideration of variances, without the cost of these reviews falling on the shoulders of local governments.



I am writing to provide you with an update regarding the ongoing arrivals of Syrian refugees into British Columbia (BC) communities. I am delighted to see the outpouring of British Columbians' support for arriving refugees—in just the past few weeks we have seen hundreds of new arrivals welcomed into communities across the province from Victoria to Fernie to Prince George.

Refugee arrival numbers are continually evolving. As I mentioned in my previous letter, the federal government has created a website to provide up-to-date information on refugee volumes and settlement locations, available at: <a href="www.cic.gc.ca/english/refugees/welcome/map.asp">www.cic.gc.ca/english/refugees/welcome/map.asp</a>. For your convenience, I have attached the most current data as an appendix.

From November 4, 2015, to January 17, 2016, between 923 to 944 Syrian refugees have arrived in BC. So far, 783 have arrived in Vancouver, and the remainder are divided between 18 other communities. Another six communities can expect arrivals in the near future. According to the data the Province has collected so far, over 60 percent of arrivals have been children and youth, and the average family size has been quite large at 4.8 people. Among privately sponsored refugees who settle outside of Vancouver, families are on average much smaller (2.4 people) and are more likely to be working age.

You may have heard that the Immigrant Services Society of BC (ISSofBC), the organization that provides initial reception and support for government assisted refugees, asked the federal government for a temporary pause on the arrival of refugees from January 19 to 22. This is consistent with the strategic approach to the federal government's refugee resettlement plan, and several other cities across Canada have also requested a pause to allow service providers to catch up on transitioning refugees into permanent housing. During the brief pause of government-assisted refugee arrivals, privately sponsored refugees will continue to arrive in communities across BC.

The provincial government continues to take a cross-ministry coordination approach to address issues arising from this influx of new British Columbians. Currently, our most pressing focus is to support the federal government in securing permanent housing that can accommodate large families. We continue to work closely with the federal government, who have full jurisdiction over the refugee resettlement program, to coordinate our efforts as much as possible.

As I have indicated in previous correspondence, ISSofBC has created an online registry for private offers of support for Syrian refugees, including housing, employment and volunteer offers. ISSBC also publishes weekly newsletters about the progress of refugee settlement in BC. I encourage you to share this link with your members and their communities: <a href="https://www.issbc.org/refugee-readiness-hub">www.issbc.org/refugee-readiness-hub</a>.

Please feel free to share this letter with your members as appropriate. Thank you again for your time and ongoing commitment to the refugee settlement process in BC. I look forward to our continued engagement on this matter.





Re: Next Generation Radio Program: Progress Update

Dear Mayor Buhr and Council:

I am writing to provide the Lions Bay Council with an update on the planned replacement of the regional radio system — a project known as the *Next Generation Radio Program* (NGRP). As you are aware, Lions Bay Fire-Rescue uses the existing E-Comm radio network for fire communication and will transition to the new digital system over the next two years alongside other emergency service agencies in both Metro Vancouver and the Fraser Valley.

Over the past year, E-Comm and its partners in police, fire and ambulance have been working with Motorola on finalizing network design and just recently completed a very successful pilot test of the network infrastructure. The objective of the pilot test was to thoroughly test all aspects of the network infrastructure to ensure it meets user performance and functionality expectations.

I am pleased to report that in December the Next Generation Radio Program Working Group and the E-Comm User committee—both composed of police, fire and ambulance representatives from across the Lower Mainland—endorsed the results of the pilot testing. Feedback received from the user agencies that participated in the testing has been positive, with the mission-critical components of the system performing reliably and audio quality surpassing expectations.

We are also nearing the issuance of the last major component of the NGRP procurement process; the release of the subscriber equipment Request for Proposal (RFP). Once the RFP has been issued, communication on the NGRP will be limited as this competitive process unfolds. This RFP process is expected to identify and secure costing data for multiple approved suppliers of user equipment. Users will be able to make their choice among these suppliers. The successful proponent(s) will be announced when contracts have been signed.

High-level discussions continue with agencies around transition planning to the new network, with the goal of addressing any issues/constraints related to their respective transition onto the new network in advance and to develop an overall transition plan with go-live dates defined and agreed for each agency.

I would like to take this opportunity to reassure you that this major capital infrastructure project remains on track and on budget and to extend E-Comm's appreciation to all members of the NGRP Working Group and User Committee for their expertise, input, guidance, and dedication to this initiative.

\* Please note this incident took place yesterday, Wednesday January 28th, 2016. It was posted on my blog and tweeted to Mayor Robertson at that time.

Dear Mayor Robertson and Members of Translink Board and Council:

Something happened to me today in a Vancouver Taxi that should never happen to anyone and you must take immediate steps to ensure it never happens again.

I am still very shaken by this incident so I will do my best to relay this information as clearly, succinctly and accurately as possible but ask your understanding if emotion creeps in.

I want you to understand while this situation – which very nearly became a matter for the Vancouver Police Department – may be rather extreme; I do not believe incidents like this are nearly as isolated as they should be.

I am a Vancouver resident with an autoimmune disorder that has weakened my muscles to the point that I can no longer stand or walk and thus use a manual wheelchair.

As a result I am a sometimes user of HandyDART.

I say sometimes because whenever possible I use regular public transport.

I am glad to live in a city that has accessible transit.

Unfortunately, of late, due to some complications from my illness, I suffer from rather significant motion sickness, a condition that seems particularly exacerbated by riding backwards, as is required on buses.

Today I needed transportation to attend a committee meeting at St. Paul's Hospital. I recently joined the committee because that hospital, and in particular one doctor, saved my life in all the ways that phrase can mean. Volunteering is my paltry attempt at repayment and is no doubt far more meaningful to me than the hospital.

This was to be my first meeting.

Near the end of the pick-up window (as you may be aware HandyDART rides are scheduled to come within a 30 minute time frame), I called dispatch to check the status and was informed that it would be a taxi instead of a HandyDART bus.

You would think this would be good news – direct to your destination instead of a sometimes long, meandering series of pick-ups and drop-offs – but, in my experience using taxis both through HandyDART and on my own, it often isn't.

The dispatcher informed me the taxi company was having trouble finding a wheelchair van but one should be there around ten minutes after the end of my pick-up window. This was not a problem, as I would still arrive in time for the meeting.

The taxi actually arrived earlier. I was relieved.

Once in the van, the driver, as has happened on multiple occasions with multiple taxi drivers, suggested that he did not need to secure my wheelchair.

He asked me where I was going and then announced that since it was relatively short trip, one strap instead of four, would suffice.

Once, in the past, tired and feeling ill, I gave into a driver who only wanted to put one strap on my wheelchair — actually he didn't want to put on any but I managed to work him up to one. When we turned the first corner the wheelchair tipped — it was a power chair — the only thing that prevented me from falling completely was that my head wedged into the side of the van. I had a sore neck for about a week after that.

Since then I have insisted drivers secure the chair as they are trained and, I believe, regulation requires them to.

Thus I told this driver that I needed him to use all the straps – 'please'- and to secure the wheelchair properly.

He argued.

I insisted.

He was not happy. He handed me a seatbelt strap from the backseat and suggested I hang onto that instead – as if I were riding a bull in a rodeo.

I said I did not find that to be an appropriate substitute.

He then put the front straps onto the wheelchair but hooked them to the spokes of my wheels instead of to the frame of the chair. I asked him to move them to the frame of the chair. He refused to listen. He insisted they would be fine there. At that point I looked behind me and noticed that the back straps – the ones I actually believed were already secured to the frame of my wheelchair – were not attached to at all and were simply lying on the floor.

Now I want to be very clear about this – I have negotiated with many drivers reluctant to do their job properly so this is not a novel event. I have also walked several through the process of properly securing a wheelchair and not permanently damaging my wheels. What made this situation different was this driver's refusal to listen to

me or in any way respect my wishes.

At this point I said, 'You know what, I don't think this is going to work out. I will call for a different ride. Please let me out.'

And this is when things escalated out of control. He ignored my direct and explicit request to be let out of the taxi – over and over again.

In turn I transitioned from being exasperated and annoyed to being angry and fearful.

I was now literally trapped. I was a disabled woman trapped in a vehicle at the mercy of a man who had demonstrated complete disrespect and disregard for my safety and my wishes.

It was only after I pulled out my cell phone and told him that I was going to call the police if he did not let me out of the taxi that he finally relented.

I would estimate that I first asked – then demanded – to be let out of the taxi at least 10 times before that.

By that point I was in full fight or flight mode. I did not swear or become abusive but the volume of my voice did escalate. My sole focus became getting out of that van as quickly and as safely as possible.

I think this experience would be unsettling to anyone but I don't know for sure because I am not anyone.

I am a woman with a disability. I am also a woman who has experienced violence.

It has been more than 5 hours since this happened and I am left dealing with all the feelings it resurrected.

By the time he finally let me out of the taxi I was shaking.

A few minutes later a taxi driver from a different company (Black Top) happened to pull up and overheard me talking on the telephone to HandyDART about what had just happened. He offered to drive me without charge to my meeting.

I am sure I did not present, as I would have liked to, at my first meeting with the committee.

At the end of the meeting I found myself unwilling to risk getting into another vehicle with a stranger. I did not want any more arguments about whether my safety was worth the 30 seconds of effort it takes to secure my chair. And I did not want to feel that awful sense of utter helplessness I felt trapped in the back of that van.

So I cancelled the ride and wheeled home.

I have a ride booked for tomorrow. I am still not sure if I will cancel that ride. I cannot wheel there and for the moment at least, the bus is not an option for me. So that means I will have no transportation options and thus will have to remain at home.

I don't think the current options are acceptable and thus I turn to you.

I try very hard not to complain without offering solutions so here are some preliminary thoughts on what needs to happen – NOW – not sometime in the future. I am willing to help make them happen:

- 1. I would like to volunteer to help develop new training models and standards for taxi drivers. Whatever training they are getting, it isn't working. It may be the content or it may be the delivery, but clearly there is a problem. And it is a problem that may cost you in lawsuits if it is not addressed.
- 2. Taxis are not a substitute for HandyDART and should not be used as such. Users of HandyDART deserve to know they will deal with properly trained drivers and I do not believe the training and screening for a taxi driver to be in any way comparable to that of a HandyDART driver, nor will it ever truly be. If I call HandyDART for a ride I want and need a HandyDART driver. Taxi drivers need better training but they will never be substitutes.
- 3. There needs to be a very clear, well-advertised public process for reporting and dealing with complaints around taxi drivers. This data needs to be fully documented and bi-monthly reports including all recorded incidents must be reviewed by council and made available to media and members of the public (with private identifying information redacted of course). Dealing with these situations as isolated events and within the companies themselves, almost certainly guarantees they will be repeated.

Doing nothing is not an option.

Here is a small sample of some of my experiences:

- 1. Taxi driver dropped me off at VGH, the Centennial Building entrance. I am adjusting myself and without warning he was very impatient and I assume wanted me out of the way faster began pushing my wheelchair up the sidewalk cut. This cut has a small lip and if I do not properly adjust my weight, the chair will and did tip. I did a full faceplant onto the sidewalk. I was pretty badly bruised on my hands and legs for a few weeks after. I called Vancouver Taxi and spoke to the manager but no action was taken that I am aware of.
- 2. Pushing me without asking first is an ongoing problem. While I am a full human outside of the chair, when I am in it, the chair becomes something of an extension of me. You would not go up and push someone who was standing without speaking to them nor would you grab their bag out of their hand without asking, even if your intent is to be helpful. I have had several near faceplants since.
- 3. Recently I attended a conference at the Vancouver Club. I asked to be dropped off at the back. The driver stopped on the opposite side of the road in the middle of the block and told me to get out there and make my way across lanes of rush hour traffic. This is particularly dangerous in a wheelchair. When I asked him to go around the block he slammed the door and used various obscenities including the one that starts with F.
- 4. When the meter is put on is different with different drivers and as a result one day I called the manager of Vancouver Taxi to check on the policy. I was told the meter is supposed to be put on once I am in the taxi. On one occasion the taxi drove up, the driver spent some time in his van talking on the phone then rearranging papers. He then got out, opened the back of the van and began moving things from the back of the van to the back seat. By the time I got in the van the meter was already over \$5.00 so I mentioned this to him. He became very belligerent and turned the meter off entirely and told me to just pay him \$8.00 and said the former mayor of Vancouver never minded when they started the meter early and that it was 'the law.'

Here's what I have not objected to ever -

- 1. The loud conversations most drivers have on their cell phones while driving and the fact that they react like I am intruding on their private time when I have to give them directions.
- 2. Their choice of music whatever it is, I don't mind. Often I enjoy it but it would be nice to be asked once in a while
- 3. The fact that none of them seem to know their way around UBC campus or a host of other places.
- 4. The tremendous resentment some drivers harbour to 'having' to deal with people with disabilities.

I would really like to have taxi drivers who don't act like they doing me a favour picking me up, but that may never happen.

I am sure I am not a perfect customer but I think I am a decent one. I almost always give a tip — if I don't it is a statement and I can count the number of times I made that statement on one hand. (One being the faceplant.) I cut them some slack — it's a tough job with few rewards and we all know Vancouver is not the friendliest place so I can imagine they spend a lot of time being treated unfairly. I can empathize with that and I try not to do it. And, a good number of taxi drivers are very professional and courteous. The other night I had one play some of his favourite songs for me. It was nice.

Today I felt backed into a corner. I felt frightened.

I don't want this to happen to me or anyone else again.

Let's make sure it doesn't.

I look forward to hearing back from you at your earliest convenience and working together to address these problems in the prompt manner they warrant.



#### Environnement et Changement climatique Canada

(La version française suit)

On October 6, 2015, the Committee on the Status of Endangered Wildlife in Canada (COSEWIC) submitted 55 assessments of species at risk to the federal Minister of the Environment.

On December 23, 2015, the Government of Canada posted the Ministerial Response Statements for these species on the *Species at Risk Act* (SARA) Public Registry. The Government is now launching public consultations on the potential amendment of Schedule 1, the List of Wildlife Species at Risk under SARA. The complete set of statements and the consultation path (normal or extended) for each species are available at: <a href="https://www.registrelep-sararegistry.gc.ca/default.asp?lang=En&n=9953B034-1">www.registrelep-sararegistry.gc.ca/default.asp?lang=En&n=9953B034-1</a>.

Environment and Climate Change Canada is seeking comments on the proposed amendment of Schedule 1 resulting from assessments of 25 terrestrial species. Nineteen of these are eligible to be added to Schedule 1, while four are being considered for up-listing to a higher risk status and two are being considered for down-listing to a lower risk status. Twenty additional terrestrial species at risk have had their current Schedule 1 status confirmed. These are not included in this consultation process, as no regulatory amendment is required.

Fisheries and Oceans Canada is conducting separate consultations for four aquatic species eligible for an addition to the list or a reclassification. An additional four aquatic species are status confirmations, one was assessed as Not at risk and one is a reclassification. These latter six species have no potential regulatory impact, and thus public consultations are not required.

Additional information on the listing and consultation processes for terrestrial species, as well as the possibility to amending Schedule 1 by adding or reclassifying species, are available in "Consultation on Amending the List of Species under the *Species at Risk Act*-Terrestrial Species: January 2016". This document also includes a questionnaire that provides you guidance on the types of information and comments Environment and Climate Change Canada is seeking. It is posted on the SARA Public Registry at: <a href="http://www.registrelep-sararegistry.gc.ca/document/default-e.cfm?document/D=2749">http://www.registrelep-sararegistry.gc.ca/document/default-e.cfm?document/D=2749</a>.

You are invited to submit comments on the potential impacts of amending the List of Wildlife Species at Risk according to these COSEWIC status assessments. Your comments will be considered and will inform the Minister's recommendation to Cabinet. Please provide remarks by **May 4, 2016** for species under a normal consultation process. Three terrestrial species, namely the Caribou (Newfoundland population), the Eastern Wolf and the Red-necked Phalarope, will follow an extended consultation process. Please provide remarks by **October 4, 2016** for species following an extended consultation path. There will also be an opportunity to provide comments during the 30-day public consultation period associated with pre-publication in Canada Gazette Part I. More detailed information on individual species is included in the COSEWIC status reports, which are available on the SARA Public Registry. The Public Registry also provides more general information about SARA.
