1. Complete this application form and email, mail, or deliver it to the Chief Election Officer (election@lionsbay.ca or Village of Lions Bay PO Box 141 400 Centre Street, Lions Bay, BC V0N 2E0).
2. If your application is complete and you qualify to vote by mail ballot, a mail ballot package will be sent to you as soon as the ballots are available. If we receive your application after Monday, October 10, 2022, the time may be insufficient for mailing and receipt of the ballot; we recommend that you arrange to pick up a mail ballot package from the Village of Lions Bay Municipal office.
3. You are responsible for ensuring that your completed ballot and documents are received by the Chief Election Officer before the close of voting at 8 pm on Saturday, October 15, 2022.

- not disqualified by law from voting in an election or otherwise disqualified by law.
