# Announcement: Early Notification Letters will NOT be Sent to Property Owners this year

Due to the Canada Post disruption BC Assessment (BCA) will not be sending the early notification letters (ENLs) to selected property Owners for the 2025 Roll Year.

ENLs are intended as a courtesy to provide advanced notice to property owners that they will see a change in their upcoming assessment and to warn that their property taxes may change as a result.

For your reference, BCA has decided to produce the extract of the folios that would have received ENLs. Should your staff receive any inquiries regarding these missing letters, please refer the property owners to their local BC Assessment area office. The best ways for them to connect with us is by phone at 1-866-825-8322 or by email at connect@bcassessment.ca.

To see a list of all folios in your Jurisdiction, log into **bcassessment.ca** using your BCeID to retrieve from the "Roll report" folder a file called *Early Notification Letter Mailout Extract*.

Note, when viewing the Early Notification Letter Mailout Extract file:

The presence of content in Column L 'Value Change Reason' indicates that a folio has been included within the early notification letter folio list due to a value change. If Column L is blank, the folio was included due to an exemption and/or classification change.

We have been made aware of recent cougar sightings in the area. If you spot a cougar, remain calm and do not approach it. Keep a safe distance, make yourself look larger by raising your arms or holding a jacket, and slowly back away. Do not run, as this may trigger a chase response. If you feel threatened, make loud noises or use an air horn to scare the cougar away. Keep an eye on pets, and ensure trash is securely stored to avoid attracting wildlife.

# Would Spring still be Spring without hummers?

Rufous Hummingbirds have the longest migration in the world based on distance travelled and size. They return from their wintering range in Mexico and the Gulf States to the same area, often to the same nest and feeder, each year. But their populations have declined by more than 67% since 1966. What if your hummers never came back?

The Bird Friendly City program works to protect birds, their habitat and food sources to support bird populations. We focus on educating all ages about the importance of caring for nature, biodiversity and eco-systems, not just for birds, but also for other wildlife and human well-being.






