#### 6. Unfinished Business

### A. Recycle BC

Discussion on collaboration with staff on progress towards getting equipment placed and logistic hurdles addressed. Council reminded the committee that the depot was supported by council resolution and will get done. Request to staff was to nominate a project champion to see its implementation through.

#### B. Hall Upgrade

Discussion on hall upgrade grant money and associated timelines ensued. Focus on how to stage the project and spend against the grant deadlines. A certain portion needs to be spent by March and the committee discussed what to advise council to commit to first. The committee advised that an electrical study and resulting recommended power upgrade strategy be implemented to facilitate heat pump upgrade and optimize building power distribution.

The discussion shifted to back up heat in a power outage and the committee recommends that fireplace be upgraded to a closed unit with a blower to facilitate hall heating and warm refuge for residents in a cold power outage scenario. The power upgrade scope of work should include a 120V circuit to facilitate the fire place upgrade and power the associated blower.

#### C. Nature Based Solutions

The request for promotion of nature based solutions via grant funded communication project was put to the committee and supported by the committee. The communication is to raise awareness around nature based solutions in and around our communities.
