NOTICE OF PUBLIC HEARINGS

Location of Hearing: Council Chambers, 400 Centre Road, Lions Bay, BC

Pursuant to the provisions of the *Local Government Act*, two public hearings will be held to consider the following bylaws of the Village of Lions Bay (the "Municipality"):

#### Hearing # 1 Zoning and Development Bylaw No.520, 2017, Amendment Bylaw No. 650, 2025 - Setbacks

Proposed text amendment to Section 7.7.2 of Zoning and Development Bylaw No. 520, 2017, correct a technical inconsistency and clarify the intent of the setback averaging provision applicable to the Brunswick Beach Overlay Area.

#### <u>Hearing # 2 Zoning and Development Bylaw No.520, 2017, Amendment Bylaw No.641, 2025</u> - Short Term Rentals

The proposed updates to the STR Policy and Zoning and Development Bylaw No. 520, 2017, are necessary to achieve compliance with provincial legislation and to strengthen the legal enforceability of municipal STR regulations. By refining definitions, clarifying conditions, and eliminating problematic provisions, these revisions ensure that the policy and Bylaw function effectively.

These bylaws apply to all single-family residential properties (RS1) within the Municipality. All persons who consider their interest in property to be affected by the proposed bylaw will be given a reasonable opportunity to be heard or to present written submissions respecting matters contained in the bylaw.

Written submissions, mailed to PO Box 141, 400 Centre Road Lions Bay, BC, VON 2E0 or emailed to office@lionsbay.ca, will be accepted up to the close of the hearing, and will form part of the public record. Mayor and Council are not permitted to receive further input following the conclusion of a Public Hearing. 


Earthworks for the new playground equipment




Neptune Technologies is making good progress on our water service location census, the forerunner to upcoming property metering installations. With zero interest in one, the mooted Metering Townhall is off. But there are answers to Frequently Asked Questions on the municipal website at All-Zone All-Property Water Metering 2025/26.

Trail counter tampering, damage and disappearances since last Fall have hampered our ability to track hiker traffic, but Publics Works finally has useful data for August, September and October-projected:



July, lost, is usually our busiest month, but even August, at over 15,000 out and back hikers (yes, we halve the reading count), is approaching double 2024, and September and October are also significantly up on last year and years before. That's not unexpected from what we saw in the field. Most of the demand is on the weekends:


